For reasons of death or substantial disability by providing death certificate or disability statement by certified physician, if the Dojo goes out of business and fails to provide facilities within 10 miles of, or moves its facilities more than 10 miles from current location, and/or agreement has passed the period of 36 months, the agreement is nullified and is automatically cancelled.
- **Automatic Renewal:** Due to continuing nature of physical fitness and in order to serve the member(s)/student(s) as efficiently as possible, this agreement shall automatically be renewed for one year upon expiration unless written notice is provided at least one month prior to the expiration date of this agreement (same as program’s “End Date” under section 3 – course description). If there is any price increase or change in the course fees, the automatic renewal will reflect all or any such increase in the fee(s).
- This agreement along with Prior Medical Condition Declaration, Sil Jeon Do Rules and Regulations and Sparring Rules comprise the entire agreement pertaining to membership and no other agreement of any kind will be recognized by Sil Jeon Do mixed martial arts school.

**Section 7: MEMBERSHIP AGREEMENT**

This agreement executed the date shown on this agreement by and between Sil Jeon Do hereinafter referred to as the Dojo/School/Center, and the Student/Member / Parent/Guardian, who has caused his/her signature to be affixed hereto, hereinafter to as Member/Student/ Parent/Guardian of the student.

The school/dojo agrees to provide instruction in Sil Jeon Do to the member/student during the scheduled instruction hours of the school/dojo. Member/Student / Parent/Guardian understand that it is his/her responsibility to attend the instruction sessions. Member/Student / Parent/Guardian understands that the entire course fee stated front is due and payable according to the terms of his agreement whether or not student/member chooses not to attend instructional sessions provided by dojo/school. In consideration for dojo's promises to instruction facilities, member/student / parent/guardian agrees and promises to pay the course fees shown on this agreement.

In the event of default in the payment of any installment or fee in accordance with the terms above, or as breach of any of the covenants herein contained to be performed by the member/student / parent/guardian, the balance due under this agreement shall become immediately due and payable in full term of the agreement.

Member/Student / Parent/Guardian agrees to abide by the rules and regulations governing the conduct and operation of instruction sessions, students and observers, in order to promote efficiency, safety, and recognition of the instruction certification, as prescribed by the Dojo/School. Member/Student / Parent/Guardian acknowledges that rules and regulations governing the dojo/school have been adopted, and may be changed from time to time, and Member/Student / Parent/Guardian agrees to abide by all such rules and regulations as adopted or hereinafter amended. The hours of operation may be changed at the discretion of the Dojo/School. The dojo/school reserves the right to revoke or terminate any membership.

Member/Student / Parent/Guardian agrees that all exercises and/or courses are undertaken at member/student's risk. Member/Student / Parent/Guardian understand the procedures and exercises involved in instruction and participation as explained to him/her/them by an assistant of the Dojo/School. Member/Student / Parent/Guardian understand that there is a risk of personal injury involved in the course of instruction and with this knowledge agrees to indemnify and save harmless the Dojo/School from all losses caused by accident and/or injury to the member/student, or to the third person(s), who may be with the member/student of the dojo, in the event that either the student/member or said third person(s) is injured in any way during the performance and execution of exercises.

The company owning the dojo/school and the agent(s) amd employee(s) shall not be responsible for damaged, lor and/or stolen articles, inside or outside the facility.

The Dojo/School reserves the right to amend and/or add to these rules and conditions and no adopt new rules and conditions as it may deem necessary.

If the Member/Student / Parent/Guardian desires to transfer his/her membership to another individual, a transfer fee will be assessed to cover dojo/school costs which will not exceed \$50.00. Membership obtained on a special are non-transferrable or freezable.

I, the Member/Student / Parent/Guardian, irrevocably authorize Dojo/School, its successors and assigns, and those acting under its authority, to copy, use, publish, for art, advertising, trade, or any other lawful purpose whatsoever, photographic portraits, pictures or videotapes of me, in which I may be included in whole or in part.

In consideration of the training obtained, I agree that I will not, during the continuance of this agreement, and for a periof of five (5) years following termination of my association with the Dojo/School, engage in teaching Sil Jeon Do style mixed martial arts or offer similar training or instruction within fifty (50) miles radius of any school operated by the School/Dojo without the express written authorization of same.

Should you, the Member/Student / Parent/Guardian, choose to pay for more than one month of this agreement in advance, be aware that you are paying for future services and may be risking loss of your monies in the event this martial arts dojo./school and/or dojo/school location seizes to operate. This martial arts dojo/school is not required to provide any security, and there may not be other protections provided to you should choose to pay in advance.
